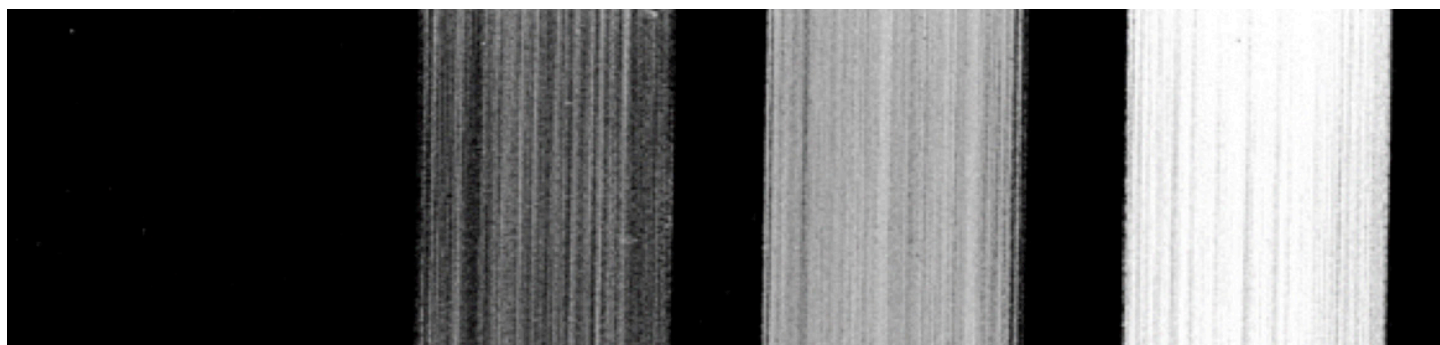
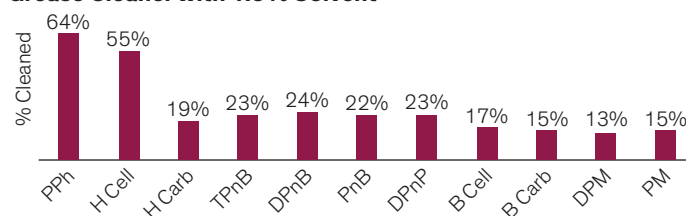
**Lime Scale Cleaner with 1.5% Solvent**
