How to Use

To optimize the dispersion of DOWSIL™ CE-8170 AF Microemulsion into the final formulation, it is recommended to add it slowly at the end of the procedure at a temperature below 40°C (104°F) with continuous mixing.

Recommended use level is 2–10% for hair care formulations.
