This emulsion was developed as a conditioning additive for hair care products such as shampoos, conditioners, styling aids and hair colorants. This product provides conditioning benefits on dry and wet hair as well as slipperiness on wet hair. It is also provides heat protection benefits allowing to preserve hair resistance to breakage. DOWSIL 969 Emulsion facilitates styling since it

allows to have more aligned hair after blow drying and to reduce the number of iron passes to optimum straightening. It also enables straightened hair to maintain much longer its styling. DOWSIL 969 Emulsion provides good stability with dilution.

#### **HOW TO USE**

To optimize the dispersion of DOWSIL 969 Emulsion into the final formulation, it is recommended to add it slowly at the end of the procedure at a temperature below 40°C (104°F) with continuous mixing or stirring.
