Procedure

Step	Process			
1	Heat ingredient 1 to 70°C.			
2	Disperse ingredient 2 into ingredient 1 and mix until homogeneous.			
3	In a separate vessel, combine phase B ingredients and mix.			
4	Heat phase B ingredients at 70°C using a water bath.			
5	Mix phase B ingredients together until all ingredients are completely dissolved.			
6	Add phase A to phase B in increments and stir while keeping phase B warm enough to keep the wax melted. Stir until homogeneous.			
7	Cool to room temperature while gently mixing.			
8	Add phase C ingredients in order listed mixing well after each addition.			
9	Adjust pH to 4 with citric acid solution.
