## Procedure:

- 1. Mix phase A ingredients together.
- Premix the pigments of phase B together using a specific device for powders (coffee grinder).
- Add phase B to phase A while mixing (300 RPM) homogeneously.
- Add phase C to phase AB and mix (300 RPM) until getting a homogeneous dispersion (~10 min).
- 5. Mix phase D ingredients together..
- Add phase D to phase ABC slowly under mixing (800-1200 RPM).
- 7. Add phase E ingredient while stirring.
