Application

PRIMAL™CA-600 acrylic emulsion polymer is a water based contact adhesive to bond various substrates, such as wood, laminates, metal, leather, plastic substrates, misc. textiles, as well as carpets, moldings etc. It could be used in DIY and industrial contact adhesives.

PRIMAL CA-600 acrylic emulsion polymer shows excellent green strength and develops high shear strength rapidly. It has outstanding contact ability using low pressure. Due to the chemistry of the polymer PRIMAL™CA 600 acrylic emulsion polymer is resistant against UV-radiation.

Formulation Guidelines

PRIMAL TM CA-600 acrylic emulsion polymer is ready to use. It does not need to be formulated with other additives. As a rheology modifier (depending on the packaging: tubes, pails, etc...), we recommend our ACRYSOL TM RM 2020 rheology modifier product.

The addition of 5% (solids/polymer solids) of a further improves the high temperature creep resistance, while maintaining the excellent contactability.

Formulation Guidlines

PRIMAL™CA-600 acrylic emulsion polymer is preserved. However, if it should be formulated/blended with other emulsions, the addition of additional biocide (such as KATHON™) is recommended.

Storage and Handling

PRIMAL™CA-600 acrylic emulsion polymer should be stored at temperatures between 5°C and 40°C in tightly sealed containers. Avoid freezing of the material! Local legislation on storage must be followed.

PRIMAL CA-600 acrylic emulsion polymer is protected against microbial attack during transportation and storage in not opened original packaging. To avoid problems with microbial attack during processing and in opened packaging attention should be paid on hygiene. In some cases it could make sense to add biocides to avoid problems with microorganisms.

We recommend using the product under safety precautions as described in the SDS. Avoid contact with eyes and skin. Large quantities should be handled in a correctly ventilated area. Material can create slippery conditions
