PRIMAL™ CA-162 Acrylic Dispersion

Product Description

PRIMAL™ CA-162 Acrylic Dispersion is manufactured without added solvent (no solvent intentionally added). It is an acrylic binder specifically designed for use in high-performance low- modulus pigmented sealants and in flooring adhesives.

Applications

PRIMAL™ CA-162 Acrylic Dispersion is a high solids (62 %) low Tg binder. Sealants formulated with this binder typically show high adhesion, even after long time outside exposure. They can contribute to provide a perfect sealing, with moderate stress on the joint surfaces, and no risk of disaggregating fragile substrates, such as porous concrete.

Formulations with PRIMAL CA-162 Acrylic Dispersion are expected to easily pass international norms for facade joint sealants such as ISO 11600 (type F, class 12.5P) or SNJF (type plastic, 1st category). Flooring adhesives formulated with PRIMAL CA-162 Acrylic Dispersion usually comply with EMICODE E1 and offer high adhesion to linoleum and carpet floorings.

Storage and **Handling**

PRIMAL™ CA-162 Acrylic Dispersion should be stored at temperatures between 5°C and 40°C in tightly sealed containers. Avoid freezing of the material! Upon purchase, applicable legislation on storage must be maintained/followed. PRIMAL CA-162 Acrylic Dispersion is protected against microbial attack during transportation and storage in not opened original packaging. To avoid problems with microbial attack during processing and in opened packaging attention should be paid on hygiene. In some cases it could make sense to add biocides under your sole decision to avoid problems with microorganisms.

We recommend using the product under safety precautions as described in the SDS. Avoid contact with eyes and skin. Large quantities should be handled in a correctly ventilated area. Material can create slippery conditions.

As the product contains water corrosion-resistance equipment should be used for processing. Low shear pumps like diaphragm pumps should be used.
