Description

TAMOL™ 731A Dispersant is an extremely versatile dispersant for acrylic, butadiene/styrene, vinyl acetate/ethylene, and vinyl acrylic based coatings. This high-performance hydrophobic copolymer dispersant offers many formulating benefits, including the following:

- Very effective with inorganic pigments
- High efficiency performance
- Exceptional gloss development
- Excellent pigment wetting capability
- Excellent overall compatibility
- Good compatibility with HEUR rheology modifiers

It also offers good gloss and hiding at economical use levels. In addition, when formulated with a high-performance binder and other high-quality additives, it can offer greater corrosion resistance to coatings formulations. TAMOL 731A Dispersant can be used in a wide range of formulations, including flat primers, low VOC paints, interior and exterior flat, sheen, and semigloss paints, and glossy topcoats. It is a most generally useful dispersant, and can be expected to lend good dispersion, stability, and film properties in a broad array of coating systems.

Dispersing Efficiency

TAMOL™ 731A Dispersant should be tested at 0.5% to 1.25% active ingredient based on total pigment weight. It is important to determine the proper level for the finished paint formulation. If a low level is used, the dispersion may be incomplete providing an inadequate grind that will not maximize gloss, hiding, or stability. High levels of dispersant may lead to increased water sensitivity.
