RHOPLEX™ AC-464 Emulsion Polymer has also shown excellent performance as a solid-color stain.

RHOPLEX™ AC-464 Emulsion Polymer is designed to be an upgrade to RHOPLEX™ AC-264 Emulsion Polymer, targeted to comply with 50 g/L VOC limits and also manufactured without the use of APEO (alkylphenol ethoxylate) surfactants.
