It is designed for use in edge sealers on wood and wood composite substrates such as plywood and oriented strand board (OSB), and facilitates products with good resistance to edge swelling. RHOPLEX™ AC-1034 Emulsion offers very good compatibility with high levels of waxes which are often used in edge sealer products. It can also be used in formulating clear primer or sealer coatings to provide water resistance
