Properties obtained using a 1.2 phr DCLBP bis (2,4-dichlorobenzoyl) peroxide 50% on 2 mm thick slabs: Press cured 5 minutes at 116°C (241°F). Post-cured 4 hours at 200°C (392°F) OR using 0.6 phr DCP dicumyl peroxide 95% on 2 mm thick slabs: Press cured 10 minutes at 160°C (320°F); Post-cured 4 hours at 200°C (392°F)

Silimar results to those obtained using DCP can be obtained using DHBP, 2,5-dimethyl-2,5di(t-butylperoxy) hexane. For hot air vulcanization (HAV) we recommend to increase peroxide levels up to 1.5 phr of DCLBP to allow for possible peroxide loss during high temperature curing.

How To Use Pigmentation, Modification and Blending

XIAMETER™ RBB-2100-40 Base can be pigmented with standard XIAMETER™ pigment master batches. A comprehensive range of master batches is available from Dow.

The physical properties of this product can be modified using a range of Dow additives.

This Silicone Rubber Base can be blended with other durometer silicone rubber bases and extended fillers to produce materials with modified durometers and properties.
