How to Use

DOWSIL™ ACP-3073 Antifoam Compound must be formulated into a dispersion or emulsion prior to addition to the foaming media. Aqueous emulsions can be prepared and preserved using any of a number of commercially available emulsifiers and preservatives.

Additional ingredients that can be formulated with DOWSIL™ ACP-3073 Antifoam Compound include siloxylated polyethers, hydrophobic silica and organic glycols.
