Procedure

Step	Process
1	Mix ingredients of phase A together.
2	Mix phase B ingredients together.
3	Heat to 70°C.
4	Add phase B to phase A at 1500 rpm.
5	Add phase C with strong mixing.
6	Homogenize.
7	Add phase D with slow mixing.
8	Add phase E.
9	Cool to 45°C.
10	Add phase F with mixing.
11	Cool to 35°C.
12	Finally add phase G mixing slowly.
13	Homogenize.

Stability

Stable for 2 months at RT, 45°C, 50°C and 15 cycles of -18/45°C.
