How to Use (Cont.)

Dosage Level

Between 10 to 1,000 parts per million (active) of DOWSIL™ FS Antifoam EPL are required in most foaming systems. To determine the optimum concentration, begin with 100 parts per million of DOWSIL™ FS Antifoam EPL. The results obtained at this concentration should indicate any needed change in dosage level.
