Description

DOWSIL™ SM 8709 SR Emulsion is a milky white, amino-silicone emulsion. Application of this emulsion on a textile can impart soft and smooth texture on fabric because of the lubrication nature of silicone. DOWSIL™ SM 8709 SR Emulsion also shows color enhancement effect, especially on dark-colored textiles such as black surfaces.

How to Use

For use of DOWSIL™ SM 8709 SR Emulsion for textile treatment, it may be applied as received, diluted or formulated with other ingredients, and treated by the conventional methods such as padding. Users should determine the best dosage and application method on a small scale test prior to production. Below is an example of textile treatment test.

How to Use (Cont.)

Textile treatment example at lab:

- Prepare bath: mix DOWSIL™ SM 8709 SR Emulsion, water, additives, others
- Silicone add-on: 1% silicone on weight of fabric
- Padding: dip and nip (1 pass)
- Dry and cure at 130°C for 5 min
