How to Use

The recommended use level for VORASURF™ FF 5955 Additive is ~1 pphp for conventional foam/ combustible modified polyether foams and ~1.5–3 pphp for TDI/MDI based EO rich systems and low density systems. The optimum surfactant loading should be defined for the foam formulation.
