How to Use

DOWSIL™ 290C Curing Agent can be added after the dispersed mica binder. The suggested dosage ranges from 1% to 3% on active ingredient basis. The curing temperature in the formulation of mica binder can be 140°C to 160°C for 2 to 4 minutes.
