PRIMAL AC-261AN Acrylic Emulsion is APEO-free<sup>(1)</sup> and is manufactured without added formaldehyde or formaldehyde generators<sup>(2)</sup>.

PRIMAL AC-261AN Acrylic Emulsion is noted for its excellent adhesion on wide variety of surfaces such as wood, smooth concrete surfaces, old chalky painted surfaces, etc. It also offers excellent abrasion resistance, alkali resistance and UV resistance.

PRIMAL AC-261AN Acrylic Emulsion is low foaming and quickly develops hardness which imparts excellent dirt pick-up resistance in exterior paints formulated with it. PRIMAL AC-261AN Acrylic Emulsion facilitates the formulation high gloss, semi-gloss, sheen or flat paints.
