How to Use

VORASURF™ SZ 3601 Additive is recommended for producing HR molded PU foam. A use level of 1 part VORASURF™ SZ 3601 Additive per 100 parts polyol is suggested. The optimum additive loading should be defined for the particular foam formulation.

At the same time, additive for slab foam over-stabilizes foam in HR system and make foam tight, occasionally shrinking.
