Properties obtained using 1.2 phr DCLBP bis (2,4-dichlorobenzoyl) peroxide 50% on 2 mm thick slabs: Press cured 5 minutes at 116°C (241°F). Post-cured 4 hours at 200°C (392°F) OR using 0.6 phr DCP dicumyl peroxide 95% on 2 mm thick slabs: Press cured 10 minutes at 160°C (320°F); Post-cured 4 hours at 200°C (392°F).

Similar results to those obtained using DCP can be obtained using DHBP, 2,5-dimethyl-2,5-di(t-butylperoxy) hexane. For hot air vulcanization (HAV) we recommend to increase peroxide levels up to 1.5 phr of DCLBP to allow for possible peroxide loss during high temperature curing.

Materials were testing according to Dow Test Methods (CTM), which in most cases are similar to the ASTM standard listed above. Copies of CTMs are available on request.
